- 1. The articles of the Corporation are hereby amended to:
 - (a) vary clause 8 of the articles, which is set out in Schedule A to the articles, by deleting the first line, and the entirety of paragraph (a), of clause 8 and substituting therefor the following:

"The Corporation is authorized to establish Classes 1 to 90 as follows:

(a) **Classes 1 to 59; 61 to 90**. Class 1 to 59 and Class 61 to 90 members shall be entitled to receive notice of, to attend and, subject to the Class maintaining itself in good financial stating, is entitled to vote at all meetings of the members of the Corporation. Each Class member shall, with respect to any matter that is the subject of a vote of the members of the Corporation, have the number of votes equivalent to the number of Trustees it is entitled to elect, in accordance with the by-laws, except it shall not exercise any vote or votes for meetings at which only members of another class are entitled to vote separately as a class."
