8 - Statement regarding the distribution of property remaining on liquidation

It is specifically provided that in the event of dissolution or winding up of the Corporation all its remaining assets after payment of its liabilities shall be distributed to one or more organizations in Canada having cognate or similar objects.

9 - Additional provisions, if any

(a) The Directors may appoint one or more additional directors who shall hold office for a term expiring not later than the close of the next annual general meeting of the members, but the total number of directors so appointed may not exceed one-third of the number of directors elected at the previous annual general meeting of members.

Note: A person who makes, or assists in making, a false or misleading statement is guilty of an offence and liable on summary conviction to a fine of not more than \$5,000 or to imprisonment for a term of not more than six months or to both (subsection 262(2) of the NFP Act).

7 - The classes, or regional or other groups, of members that the corporation is authorized to establish

The Corporation is authorized to establish two (2) classes of members, Class 1 and Class 60 as follows:

- (a) **Class 1.** Class 1 members shall be entitled to receive notice of, to attend and, subject to a Class 1 member maintaining itself in good financial standing, is entitled to vote at all meetings of the members of the Corporation. Each Class 1 member shall, with respect to any matter that is the subject of a vote of the members of the Corporation, have the number of votes equivalent to the number of Directors it is entitled to nominate, in accordance with the by-laws, except it shall not exercise any vote or votes for meetings at which only members of another class are entitled to vote separately as a class.

- (b) **Class 60.** Class 60 members shall be entitled to receive notice of, and to attend at all meetings of the members of the Corporation. Class 60 members shall have no vote, except in relation to by-law amendments related to the following:
 - a. “fundamental changes”, amendments as referenced under sections 197(1)(d), (e), (f), (g), (h), (1), and (m) and 199 of the Act;
 - b. Strike or Other Benefits, as defined and referenced in the Corporation’s by-laws; except Class 60 members shall not be entitled to vote on by-law amendments related to how the amount of strike benefits is determined; and
 - c. the maximum consecutive term of office for the president, treasurer and chair, as defined in the by-laws.

Where voting is permitted for Class 60 members, including where the Act permits Class 60 to vote separately as a class, each Class 60 member shall have the equivalent of 200 votes.
